

In this newsletter we're please to announce three new acquisitions:

- ✓ 4,000 acres that includes 1,400 acres in the Truckee River Corridor, 2,000 acres surrounding Independence Lake and a full section on the western flank of Snow Mountain.
- ✓ 189 acres in Billy Mack Canyon
- ✓ A conservation easement on 52 acres in Billy Mack Canyon, adjoining the parcel the Land Trust is acquiring in fee.

The total cost of these projects is \$6.3 million.

Sierra Checkerboard

Confidential negotiations continue for the purchase of several important properties in the Sierra Checkerboard. The Land Trust, in partnership with The Trust for Public Land, is working to preserve over 6,000 acres in the northern Checkerboard. See page 4.

Truckee River Corridor Project

We are excited to announce completing several acquisitions, near Floriston and in Gray Creek Canyon. Total acreage is over 1,600.

Billy Mack Canyon

We are in escrow for 190 acres in Billy Mack Canyon near Donner Lake. This property, previously closed to the public, affords an array of recreational opportunities at Truckee's doorstep. See page 6.

Sierra College Conservation Easement

In terms of geographic size, Truckee is the ninth largest municipality in California, so protecting scenic vistas and greenbelts within the Town is critical to our community's character. We recently signed a conservation easement to protect McIver Hill (aka Hippie Hill). See page 12.

Campaign for Martis Valley

The Land Trust will receive millions of dollars for land preservation in the Martis Valley as a result of settlements between developers and advocacy groups.

We plan to use these funds to help protect the Valley's rich biological resources and recreational open space.

Land Trust Set to Close on 4,000-Acres

By the end of the year, the Truckee Donner Land Trust and its steadfast partner, The Trust for Public Land, will close on 2,000 acres surrounding Independence Lake and 640 acres in the North Fork of the American River drainage that includes parts of Snow Mountain. This is the final phase of a project involving nearly 4,000 acres. The other properties, acquired in June, included 1,400 acres in the Truckee River Watershed.

Costs of the acquisitions are over \$5,000,000 with funding coming from the Proposition 40 River

Parkway grants, administered by the State Resources Agency and Preserving Wild California, a program of Resources Legacy Foundation Fund.

Fran Herbst, Director of Acquisitions for Tahoe National Forest, sent a telling email of the importance of these lands:

"Saturday, Larry Gruver and I finished the inspections of all the Independence Lake parcels; I want to thank you from the bottom of our hearts for the gift





of these lands to all Americans. Larry and I have both worked on this forest for many years but saw some of the most spectacular country we have ever seen on the Tahoe National Forest. And that's saying a lot. We can't tell you how much we appreciate this. One view almost made me cry...but I was too busy laughing. Thanks so much."

The Independence Lake and Snow Mountain properties will eventually be conveyed to the USFS while the State of California will eventually hold title to The Truckee River Watershed parcels.

All of the properties are a part of the larger "Sierra Checkerboard."
This is a several thousand-acre mosaic of public and private ownership, resembling, of course, a checkerboard. This ownership pattern dates back to the construction of the transcontinental railroad in the 1860's. As an incentive to build this dangerous and expensive railroad, the Federal government offered to grant the railroad companies every other square mile of land

along the route, reserving the rest to become National Forest. If these private parcels are not acquired for protection and proper management much of the forest land in our corner of the Sierra will convert to rural sprawl over the next 10 to 20 years. This will decimate habitat and recreation opportunities, increase congestion, facilitate the spread of disease among flora and fauna, and further complicate fire management.

Billy Mack Canyon: New Acquisition at Truckee's Doorstep

The Truckee Donner Land Trust Announces the Acquisition of 189 Acres in Billy Mack Canyon on Donner Summit.

The Land Trust has long eyed this scenic Canyon that lies between I-80 and Old Highway 40 because of its extensive recreational opportunities, heretofore closed to the public.

"From the board's perspective, this opportunity was compelling. Taking action to acquire the Billy Mack Canyon property was simply being responsive to our mission." said Scott Ryan, the Land Trust's board president.

The property's western edge borders United States Forest Service Land and the Pacific Crest Trail. The Land Trust and USFS eventually hope to create a trailhead off of Old Highway 40 that would link to the PCT. This would offer access to Flora and Azalea Lakes, popular summertime destinations. The property also offers extensive opportunities for rock climbing.

Billy Mack Canyon provides extensive habitat for the endangered Willow Flycatcher, as well as Northern Goshawk and Peregrine Falcon. On a recent hike of the property, fox, Northern Goshawk and beavers were spotted. Also discovered were old growth Jeffrey Pine between five feet and six in diameter.

The Land Trust is also negotiating a conservation easement on a 52-acre adjoining parcel that includes Billy Mack Flat, a stunning Meadow and wetland mostly unknown to even long time locals. The easement would allow for the construction of a trail to Billy Mack Flat and public access.

Many thanks to Nevada Citizen's Bank and Sierra Mountain Mortgage for their support.

The acquisition and easement are parts of a larger multi-million dollar campaign for open space and trails in the Truckee area that the Land Trust is pursuing. The Billy Mack Lands are also in the immediate vicinity of other land Trust projects including Blackwall and Negro Canyon.

This acquisition follows a string of successes for the Land Trust in 2005. Earlier this year, the Land Trust signed a conservation easement with Sierra College for Hippie Hill and the Land Trust will be closing on nearly 4,000 in the Sierra Checkerboard and Truckee River Canyon by year-end.

Altogether, the Land Trust has now protected over 11,000 acres in the Truckee Donner region.

The 2nd Annual Trails and Vistas: "Wind Over Stone" A Great Success!





The Land Trust began working on the Donner Lake Rim Trail in 1996. Since then we've focused our efforts on increasing visibility and making it easier to access and use the trail.

We completed our first major segment of trail last year from Tahoe Donner to Summit Lake where hikers, bikers and equestrians can enjoy a beautiful trail while continuing along the Pacific Crest Trail to Mount Judah. We will begin construction of the bike trail in this section in 2006.

This season we are pleased to announce that, with the help of California State Parks and the California Conservation Corps, we built two new bridge structures in wet Alder seeps in central Negro Canyon.



A Day on the Donner Lake Rim Trail

With the Boys and Girls Club, North Lake Tahoe -October 19, 2005

Thanks in part to a generous grant from the Teichert Foundation, The Boys and Girls Club and the Land Trust partnered on the Donner lake Rim Trail for a fun afternoon in Negro Canon. The kids, ages 11-13, provided an important community service by removing a massive amount of trash from the Canyon. Upper Gregory Creek runs down the Canon to Donner Lake through the trailhead area, so it's important to remove trash so it does not end up in the creek and in Donner Lake basin. The kids also learned about trail building techniques for minimizing erosion, wildlife habitat issues, and how watersheds work to provide water for humans and animals. The day ended with a fun hike along the Rim Trail.

Sierra College/ McIver Hill Conservation Easement

Your support helped the Land Trust negotiate an agreement to protect McIver Hill in downtown Truckee. This landmark ridge line, wedged between I-80, Highway 89, West River Street and the roundabout will be home to the new Sierra College campus and a new publicly accessible trail system-instead of commercial buildings, condos and a hotel.

The easement achieves three important conservation objectives. It protects the scenic qualities of this Truckee landmark, requires the College to make their best effort to comply with applicable sections of the Town's Development Code and provides an easement for public access and trails across the property.

We are looking forward to a long and important partnership with the College.

A Few Words About Our Work

What is baseline documentation?

The Land Trust Alliance, a national umbrella organization representing more than 1,500 land trusts across America, created a set of protocols and guidelines for land trusts called *Standards and Practices. Standards and Practices*, ensures the public sound, legal and ethical transactions and operations by their local land trusts. Truckee Donner Land Trust's Board of Directors adopted *Standards and Practices* in 1998.

An important part of *Standards and Practices* is conducting "Baseline Documentation" for properties a land trust owns in fee or holds under conservation easement.

Baseline documentation is done as soon as land is acquired to certify the original condition of the land at the time of acquisition or closing. This is separate from the initial due diligence that is also carried out before any land is acquired, such as title reports and inspections. Baseline documentation is an on-the-ground report of a property's integrity, land condition, existing features, and habitat type(s). Baseline documentation gives the land trust a starting point for developing stewardship and management plans. Truckee Donner Land Trust conducts a review of baseline documentation for all of its properties at least twice a year.

BIOLOGICAL

Sierra Nevada Checkerboard -

The Sierra Nevada "Checkerboard" is a legacy of the Federal government's 19th century land grants of alternate square miles to the transcontinental railroad companies. This pattern fragments habitat and could lead to the loss of some of our area's great recreational assets. The Land Trust, in partnership with The Trust for Public Land, is working to preserve over 6,000 acres of the checkerboard in the next few years.

Billy Mack Canyon is incredibly rich in recreational, mammal habitat, water quality, and open space resources. See featured article page 4.

Truckee River Corridor and Gray Creek -

The Land Trust announced the acquisitions of I,800 acres in the Truckee River Watershed. The acquisitions, near Floriston and in Gray Creek, are the first phase of a larger 4,000-acre conservation effort in the Truckee Donner area. These lands host large mammal habitat and bountiful fisheries with diverse aquatic species.

Pine Forest -

Stewardship plans are underway for this magnificent 130 acre parcel adjacent to Alder Creek. Pine Forest is a wide-open conifer forest that hosts healthy Old Growth Sugar Pines.

Old Greenwood -

We recently closed escrow on this 260 acre parcel that is a crucial link to Truckee's Trail System. The Old Greenwood parcel is a rich and healthy forest that has great recreational opportunities. The trails across the property will be completed by the fall of 2006.

IMPORTANCE

Winter Creek -

We are happy to own and manage this functioning wetland right in the heart of Town. This urban habitat setting is valuable for preserving open space and foraging ground for species such as Mule deer and Coyotes.

Donner Memorial State Park -

With the Trust for Public Land, we acquired more than 2,000 acres including Schallenberger Ridge, tripling the size of the Donner Memorial State Park and extending public lands from Truckee to Donner Summit. In the coming year, we will be conveying an additional 350 acres in Coldstream Canyon and on Schallenberger Ridge. Coupled with the 2,000 acres already conveyed, we are making headway on our long-term goal of protecting the entire Coldstream watershed.

William Leonard – Cal Academy

Negro Canyon -

Keeping this canyon open and undeveloped assures the protection of the migratory corridor for the Truckee-Loyalton deer herd and access to the Donner Lake Rim Trail.

Conservation Easements -

The Land Trust holds almost I60 acres in conservation easements in and around the Town of Truckee. These parcels are protected from development, and contain diverse habitat settings such as riparian corridors, wetlands, and open scenery within the town limits. There are 60 acres of land protected by conservation easements at Northstar-at-Tahoe and over 50 acres along Jackass Ridge. In addition, the Land Trust will close escrow on the 73 acre conservation easement on the Sierra College Campus formerly known as McIver Hill (aka Hippie Hill.)
